

**“2015 UTI Mustang” Sweepstakes
Official Rules**

NO PURCHASE OR ENROLLMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.

BY ENTERING THIS SWEEPSTAKES YOU GIVE YOUR CONSENT TO RECEIVE FUTURE PROMOTION MATERIALS FROM THE SPONSOR. ON THE ENTRY FORM, YOU WILL HAVE THE OPPORTUNITY TO AUTHORIZE SPONSOR TO SHARE YOUR CONTACT INFORMATION WITH FELD MOTOR SPORTS AND TJIN EDITION (ALONG WITH TJIN EDITION AFFILIATES) SO THAT YOU CAN RECEIVE PROMOTIONAL MATERIALS FROM THOSE COMPANIES.

DATES OF SWEEPSTAKES: The “2015 UTI Mustang” Sweepstakes (the “Sweepstakes”) begins at 12:00 a.m. Eastern Time (“ET”) on January 2, 2015 and ends at 11:59 p.m. ET on October 31, 2015 (the “Sweepstakes Period”). All entrants must have access to the Internet in order to participate in this Sweepstakes. Normal Internet, phone and usage charges imposed by your online or phone service provider may apply.

ELIGIBILITY: In order to be eligible for entry into the Sweepstakes, you must be a legal permanent United States resident residing in the contiguous 48 United States or the District of Columbia and 18 years of age or older (the “Entrant”). Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live, or persons living in same household, whether related or not) of Universal Technical Institute (the “Sponsor”), Feld Motor Sports, SOPUS Products, and their subsidiaries, and each of their respective parent companies, franchisees, independent dealers, affiliates, contractors, consultants, legal counsel, public relations, subsidiaries, distributors, sales representatives, retailers, website providers, webmasters, advertising and promotional, fulfillment, and marketing agencies, and any others engaged in the development, production, execution or distribution of this Sweepstakes, including but not limited to, National Sweepstakes Company, LLC (the “Sweepstakes Administrator”) herein (collectively, the “Sweepstakes Entities”), are not eligible to participate. HOW TO ENTER: Entrant must visit www.winthatFORD.com during the Sweepstakes Period and follow the link to the Sweepstakes registration page (the “Entry Form”). Entrant must complete the Entry Form, in its entirety, including, full name, physical address, city, state, zip, phone, e-mail address and date of birth. Then, click the “Submit” button to enter the Sweepstakes and receive one (1) entry into the Sweepstakes. In order for an entry to be valid, Entrant must have a valid e-mail address and must click the “Submit” button. All entries must be submitted by 11:59 p.m. ET on October 31, 2015.

Limit of one (1) entry per Entrant/email address for the entire Sweepstakes. Entrant must complete and submit all required information to be eligible to enter. Entries having incomplete information will be disqualified and ineligible to win.

Neither Sponsor nor any Sweepstakes Entity is responsible for any entry that is lost, late, misdirected or undeliverable, whether through the mail or due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the e-mail address by an Internet access provider, on-line service provider, or other organization that is responsible for assigning e-mail addresses,

or the domain associated with the submitted e-mail address. Potential Grand Prize Winner (defined below) may be required to show proof of being the authorized account holder.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations, logins, and/or any other methods, including, but not limited to, automated entry, will void that Entrant's entries and that Entrant may be disqualified from the Sweepstakes. GRAND PRIZE: One (1) grand prize of a 2015 Ford Mustang vehicle (the "Grand Prize") having a Manufacturer's Suggested Retail Price ("MSRP") of \$35,000 will be awarded. Exact model is subject to change based on availability. Vehicle color, options, and accessories will be determined at the sole discretion of the Sponsor. The Grand Prize Winner is required to comply with any and all applicable federal, state and local laws, rules and regulations including, but not limited to licensing and insurance requirements. Grand Prize Winner must have and provide a valid Driver's License and provide proof of existing vehicle Insurance Coverage (Comprehensive or Liability) at time of delivery. All applicable tax, title, registration, insurance and licensing fees are the sole responsibility of the Grand Prize Winner. Sponsor does not make, nor is Sponsor in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to the Grand Prize, including but not limited to its quality, fitness for purpose or mechanical condition; the only representation/warranty/guarantee that may be provided relative to the Grand Prize, if any, are those of the manufacturer and/or dealer. The value of the Grand Prize is taxable as income and Grand Prize Winner is solely responsible for all matters relating to the Grand Prize, including, but not limited to all applicable federal, state and local taxes that become due with respect to the Grand Prize. Total MSRP of the Grand Prize to be awarded is \$35,000. Any difference between the stated MSRP of the vehicle and the MSRP of the actual value will not be awarded.

Names of prize manufacturers are used solely for the purposes of identifications of the Grand Prize. No endorsement, authorization, sponsorship, or approval of Manufacturer for this Sweepstakes is intended or implied.

PRIZE NOTIFICATION/CLAIM: Except where prohibited, potential Grand Prize Winner will be notified on or about November 9, 2015 via the email address the potential Grand Prize Winner supplied at the time of entry (the "Notification"). Potential Grand Prize Winner will be required to complete and return an affidavit of eligibility, liability/publicity release and W-9 form (collectively the "Paperwork") within five (5) business days of receiving the Notification. Potential Grand Prize Winner must return the Paperwork within the date and time indicated in the Notification.
